CLUB BYRON Terms & Conditions

ACCOMMODATION BOOKINGS, DEPOSITS AND FINAL PAYMENTS

By accepting this booking you agree to become a Club Byron Bowling Club Financial Member which is \$5.50AUD. This must be pre-paid and Membership card will be available to collect upon check-in.

* Standard deposit is 50% of booking amount. Final payment is due no later than 30 days prior to check-in. (Bond if applicable must be received 7 days prior to arrival).

* If your arrival date is within 30 days of booking, then full payment is required at time of confirmation. Bond if applicable must be received 7 days prior to arrival).

* Schoolies rates apply to all Schoolies bookings whatever dates are booked.

* BONDS - \$1,500.00AUD Bucks, \$1000.00AUD Schoolies, Hens, Specialist Groups

* Marvell Street -For bookings greater than \$10,000, a 25% deposit is due at time of confirmation and balance to be paid 30 days prior to arrival. Bond due 7 days prior to arrival and accepted by credit card only to avoid cancellation.

* Marvell Street - For Bookings less than \$10,000, a 50% deposit is due at time of confirmation and balance to be paid 30 days prior to arrival. Bond due 7 days prior to arrival and accepted by credit card only to avoid cancellation.

Cancellations: No refunds offered - excluding bonds. Must be made via email SalesClubByron@icloud.com

In the event of a cancellation, no refunds apply. However, if cancellation/change is advised 14 days prior to arrival via email, a partial refund or opportunity to re-book new dates may be available. New dates must be advised within 7 days of original cancellation date & any additional monies due must be collected in full. Travel must be completed within 6 months of cancellation/amendment change advice. Bookings are transferable at no cost. Any additional monies due must be collected at time of confirmation. No refunds apply to any balance difference. All subject to availability and seasonality. Peak Season Bookings: Full cancellation penalties apply.

Special consideration may be offered subject to Club Byron's discretion.

KEY PICKUP & DROP OFF

Club Byron prefers all keys be directly dropped off at Club Byron main bar. If you have failed to return your keys/lost, please contact our office immediately to avoid penalties. Club Byron reserves the right to debit \$55.00AUD from your nominated credit card used upon check-in for the replacement & re-cutting of keys. We would greatly appreciate mailing keys to our nominated PO BOX address and would be happy to discuss a reversal of your deducted fee. This is subject to Club Byron's discretion. If you are arriving after opening hours, please ensure you email SalesClubByron@icloud.com or call Club Byron on 02 6685 6202 no later than 24 hours prior.

CHECK IN AND CHECK OUT TIMES

Standard Check-in: 2pm - Check-out: 10am.

Check your Itinerary/Booking Confirmation for details. If departing before 10am, please arrange/notify directly at Club Byron main bar no later than 8pm the evening prior & where you will arrange to leave keys.

Please be aware that if you do not check out by 10am, we reserve the right to charge \$50.00 per hour using your nominated credit card. Please make sure all garbage is in the bin provided and the property is tidy before leaving.

INCLUSIONS IN CABIN/HOUSE ACCOMMODATION

Linen provided includes bed sheets, pillowslips, tea towels, one bath mat, one bath towel per person. A starter kit containing toilet roll, dish-washing detergent, bin liner, sponge/scourer is also included. Cabins have a fully equipped kitchen, iron board & iron included. House has a fully equipped kitchen & laundry facilities.

Servicing can be arranged during your stay at an extra charge. Beach towels, cot linen and hair dryers are not provided.

REPAIRS TO APPLIANCES

During your stay, Club Byron endeavours to have repairs to appliances attended to as soon as possible after being reported. However due to circumstances beyond our control [e.g. having to order parts or non-availability of trade's people] immediate repair may not be possible. No responsibility is accepted by Club Byron Bowling Club. There will be no refunds or discounts. If repairs cannot be attended to, we will use our best endeavours to supply a substitute appliance or change or room subject to availability and Club's discretion.

NUMBER OF GUESTS

The number of guests must not exceed the amount stipulated in the itinerary or maximum allowed at the property. Breaches will result in bond deduction or instant eviction without refund.

HOLIDAY LETTING BOND

In any event, guests are responsible for missing or damaged items and cleaning expenses beyond the usual level for the property and will be charged accordingly. If a security bond claim exceeds the bond held, the guest agrees that any outstanding balances are to be paid directly to Club Byron Bowling Club within 1 week of notification including any associated recovery fees. An additional extended clean may be required on top of regular clean. This is calculated at \$45.00AUD per hour increments and advised same day of check-out. The guest agrees to pay the additional clean fee as per advice, BBQ Clean fee and damages within the BOND limit set. Guest nominated credit card will be used to accept payment.

A scan copy of both Credit Card & Drivers Licence must be supplied 14 days prior to arrival. No BOND is deducted by Club Byron Recreational Club, unless required due to damage etc.

Club Byron's certified Wholesale Agents require collecting FULL BOND amount 7 days prior to arrival. A Refund notification will be advised within 3 days of guest vacating. Please provide full names of all guests staying in Club accommodation. Bonds only accepted or secured using a valid VISA or Master Card.

Schoolies Bond : \$650.00AUD

Bucks Group Bond : \$800.00AUD

If bonds apply and have not been collected, Where credit card details have been provided and the bond is still outstanding 7 days prior to arrival, the last credit card used for payment will be charged. The Bond relates to any missing or damaged items, excessive noise leading to complaints, general cleanliness of the property, e.g. Left in a clean & tidy condition, washing up, BBQ cleaned to a reasonable state and rubbish removed etc. Kindly note: An higher cleaning charge of \$150.00AUD applies for the removal of any blood or bodily fluids. The signatory accepts all responsibility on behalf of all guests. This includes associated damages to Club facilities.

SECURITY CALL OUTS DUE TO EXCESSIVE NOISE – ACTIVATION OF FALSE FIRE ALARM

Security Call Outs are charged at \$165 including GST per call out. After a 2nd complaint you may be evicted without refund. Activation of a false fire alarm to NSW Fire & Rescue incurs an automatic \$1387.50AUD penalty.

Bucks & Bowls, Burger + Beer + Bowls, Hens High Tea bookings are subject to availability and weather conditions. Bookings are not finalised until deposit has been paid.

Deposits: \$75.00 non-refundable deposit upon confirmation and balance due 30 days prior. Any groups exceeding 30 adults must purchase the Exclusive Green Lane Hire Package as only 2 rinks are allocated – with approx. 8-10 adults per rink.

Any Barefoot Bowls groups exceeding 30 guests may require purchasing an Exclusive Green Lane Hire Package. See below.

EXCLUSIVE GREEN LANE HIRE PACKAGE: \$100.00AUD. (2 Green Lane Rinks)

This includes exclusive green lane rink hire available from 12 midday – 6pm during Winter & 7pm during Summer. Any functions/bookings which fall within Peak Season Exclusive Green Lanes Hire increases to \$150.00AUD. In the event a Bowling Green requires to be closed for Greens Maintenance or bad weather, a refund may apply or option to rebook new dates, this includes the use of pre-paid barefoot bowl wristbands. This is only subject to if play has not commenced & up to Club Byron's discretion. For larger groups, we suggest reserving the entire green. This can be arranged at an additional cost and is up to the discretion of Club Byron's Manager. Kindly note, availability is limited on Saturdays due to Club Pennants. Bookings essential.

BAREFOOT BOWLS

Casual Bowls available @ \$10 per person. Available for up to 30 guests.

Includes: Barefoot bowls green lane hire for maximum 2 hours – up to 3 rinks allocated. No lane allocation available & subject to availability. Pre-booked functions take priority.

Any barefoot bowls booking for over 30 guests may require purchasing the Exclusive Green Lane Hire Package above. This includes 2 additional exclusive green rink hire from 12 midday – 6pm during Winter & 7pm during Summer.

CLUB VENUE HIRE COMBO PACKAGES: A \$150.00 non-refundable deposit is required at time of confirmation to secure your reservation. Balance payment due 30 days prior to your event or if inside 30 days total balance is required at confirmation. If a function is booked inside 30 days, full payment may apply. In the event of bad weather & closing of the green, a partial refund may apply. This is subject to the discretion of Club Byron.
